If you do not have training dollars set aside for this purpose, see if you can find it. Look in your budget for unused dollars, look for donations, share the cost of driving, do what you can to reach out for more...to be the best....for the children and families of your school.

13 Ways to Get the Word Out

We're halfway through another school year, but that doesn't mean your PTA communications should be tapering off. Here are 13 ways you can reach the parents in your schools about your PTA:

1. Send emails to your membership. Encourage your members to "Share with a Friend" to reach even more parents.
2. Use the school's email service to reach an even wider audience.
3. Facebook page. You can share information from Kansas PTA and National PTA, plus create events and promote the great things your PTA does.
4. Send flyers home in backpacks. This is still a tried and true way to get the word out about what is going on in your PTA.
5. Twitter page. Millennial parents love Twitter. Get your PTA out there with short tweets.
6. Ask teachers to communicate events to students.
7. Use the school's daily announcements to mention PTA happenings. Ask the office staff to include short blurbs about your upcoming activities.
8. Utilize a bulletin board in the school's entryway/hallways. Talk to the principal about having a dedicated PTA bulletin board to post your news.
9. Hang posters around the school for visibility to the students, teachers and parents.
10. Post yard signs or banners to advertise meetings or other key events.
11. Set up a table at school events. Be present in the school as much as possible.
12. Have a PTA info table at your PTA events.

The 2017-2018 KSPTA Legislative Platform and Priorities have been recommended and approved by the Legislative Committee and will be considered and voted on by the convention body at the 2017 Convention.

2017-2018 Kansas PTA Legislative Platform and Priorities

PTA Mission and Values. The mission of the Parent Teacher Association (PTA) is to make every child's potential a reality by engaging and empowering families and communities to advocate for all children. Initiatives of the PTA are aligned with this mission and guided by five core values: collaboration, commitment, diversity, respect and accountability.

EDUCATION PLATFORM – Kansas PTA supports equitable access to quality education that provides all Kansas children the opportunity to make significant growth toward and to achieve the state education standards. The Kansas PTA recognizes no education system can be of the highest quality without the support, involvement and collaboration of parents, caregivers, legislators and the community.

Priority 1. Kansas PTA supports efforts to strengthen and improve the Kansas public school finance system, which includes legislation and policies that:

- a. uphold the state's constitutional obligations to make suitable provision for the finance of the Kansas public schools, achieving both equitable and adequate funding, as informed by actual costs and other credible non-partisan sources.
- b. pursue solutions to fully fund state and federal educational mandates, including special education, without disproportionately shifting the burden to local communities.

Priority 2. Kansas PTA will support an equitable and balanced tax policy to maintain a reliable revenue stream for public education. A policy which draws upon a combination of income, property and sales taxes has been proven by history to be a secure and sustainable approach.

Priority 3. Kansas PTA supports policies that promote professional learning communities, teacher retention and recruitment including the restoration and allocation of state funding for teacher mentoring, staff development and other evidenced-based programs and policies that promote quality instruction.

Priority 4. Kansas PTA opposes the use of vouchers, scholarships, or tax credits toward the tuition of non-public schools, with the authority to discriminate in admissions, provide sectarian religious instruction and operate under different rules of transparency and accountability than public schools.

Priority 5. Kansas PTA supports current state charter legislation, passed in 1994, which allows for the creation of charter schools under the supervision of local boards of education. Any new charter related legislation must: prohibit for-profit, private or non-education entities from serving as authorizing agencies, prohibit large scale staffing by non-licensed teachers, and must hold all charter schools to the same rules of transparency, student admission and expulsion, financial and academic accountability as other public schools.

Priority 6. Kansas PTA advocates for evidence-based prevention and early intervention programs ranging from comprehensive early childhood programs, like PreK and Parents as Teachers, to funding for all-day kindergarten, to student engagement programs that reduce dropout rates and increase school completion.

Priority 7. Kansas PTA supports the State Board of Education's routine review, revision and adoption of state education standards, including the College and Career Ready Standards (derived from the Common Core States Standards Initiative) and the Next Generation Science Standards. We encourage the State Board's continued use of stakeholder engagement throughout the revision process, including meaningful input from parents and teachers. Kansas PTA opposes legislation that would ban or defund the education standards as approved by our freely elected, non-partisan members of the State Board of Education.

Priority 8. Kansas PTA recognizes the value of collecting student data to make informed decisions about educational policy and practices and thus will advocate that data collectors be transparent and engaged with families on the development, implementation and notification about policies and procedures related to the privacy and protection of student data; and, allow for parents and families to retain the right to review and request corrections of their child(ren)'s education records or profiles.

Priority 9. Kansas PTA will support efforts to preserve the Kansas Constitutional infrastructure for education, including nonpartisan elections of Kansas school board members and their appointment of our Education Commissioner, as well as, retaining the primary responsibility of defining the state education standards, as facilitated by the Kansas School Board, Kansas Department of Education, and with input from parents, education scholars, practitioners and other education stakeholders.

Priority 10. Kansas PTA will encourage the adoption of PTA family engagement standards into relevant legislation and policy.

2017-2018 Kansas PTA

Legislative Platform and Priorities—continued -

HEALTH, WELFARE AND SAFETY PLATFORM – The Kansas PTA will support legislation and appropriations that safeguard and/or related to the health and safety of children and youth.

Priority 11. Kansas PTA supports programming and policies including the protection of children from gun violence, bullying prevention, and safe routes to school.

Priority 12. Kansas PTA supports prevention and early intervention programs and initiatives to reduce participation of youth in the juvenile justice system and to promote the prevention of delinquency.

Priority 13. Kansas PTA supports access to affordable health and dental care for children and families.

The following bylaws amendment has been approved by the Kansas PTA Board of Managers and will be considered for adoption at convention

By direction of the Bylaws Committee, I recommend in Article XII Section 6 to delete the words one dollar and twenty five cents (\$1.25) per annum and replacing them with the words one dollar and seventy-five cents (\$1.75) per annum.

Current Wording:

#Section 6. The state portion of each member’s dues shall be one dollar and twenty-five cents (\$1.25) per annum.

Suggested Wording:

#Section 6. The state portion of each member’s dues shall be one dollar and seventy-five cents (\$1.75) per annum.

Rationale:

To continue to provide the excellent support, programs, trainings, and services to our constituent associations, councils, and members by state PTA, a dues increase is needed to fund the cost associated with doing PTA business.

*Also at convention, we will be considering a consent agenda to remove from consideration three amendments that were referred back to committee at the 2016 Convention.
